5.3 Friends of the Bursary Society (Ellen)

For discussion is setting up donation categories for 'Friends of the Bursary Society'. Names would be published (with permission) on the website and in our annual report. Donors would receive a charitable tax receipt.

For example:

Platinum – Donation over \$5,000.

Gold – Donation over \$1,000.

Silver – Donation over \$100.

If a person donated \$100. over a ten-year period, they would become a 'gold' donor. This will require maintaining a spreadsheet of donors and amounts.

This would not change membership in the Bursary Society, so no need to amend the constitution.

This initiative would allow us to 'attract' individuals who do not wish to join the Club, but who support the ideals of the Bursary Society. It would also allow us to build community partnerships with no other expectations of individuals.

Discuss possibility for thank you recognition, e.g. in the fall.
