 - c) Comments: With changes to Provincial legislation changes were required to conform to the new BC Societies Act. Members of Bursary Society Board of Directors, the Club Board of Directors, Club members and especially Melanie Lautt, were thanked for their hours of work and support, consideration and thought, and debate to the resolutions. WHEREAS it is required that the Society amend its Constitution and Bylaws to comply with the new Societies Act,

THEREFORE BE IT RESOLVED that the Constitution and Bylaws of the Society be amended by deleting the existing Constitution and Bylaws, and replacing them with the new Constitution and Bylaws hereunder written in consolidated form, to take effect upon the electronic filing of the Transition Application with the B.C. Registrar.

3. Motion to approve Transition to the Societies Act, as circulated:

BE IT RESOLVED that the Directors of the Society be authorized and directed to sign all documents and take all actions that are necessary in carrying out the transition of the Society under the Societies Act, by duly registering the new Constitution and Bylaws of the Society with the Registrar.

4. Motion to approve Creation of an Endowment Fund, as circulated:

BE IT RESOLVED that the Directors of the Society be authorized and directed to create a permanent endowment fund under the name The Bursary Society (Canadian Federation of University Women – Sunshine Coast), by donating twenty-five thousand dollars (CDN\$25,000) from the existing Long Term Investment Account (Capital Fund) to the Sunshine Coast Community Foundation, the earnings from which will be returned annually to the Bursary Society to be available for its bursary program: and
